The Academic Affairs Committee at the Faculty of Law mandated the creation of a working group to follow-up on the recommendations outlined by the External Periodical Evaluation Committee in their evaluation report. The working group comprised the following members: Associate Professors Maria Madalena das Neves, Youri van Logchem, Eva van der Marel, and Senior Adviser Jørgen Ytreberg.</p> <p>It was concluded that there is the need for overhauling JUR-3054 to avoid overlaps with JUR-3050 and to be able to include newer and more relevant topics in the curriculum. Therefore, a new course is suggested to replace JUR-3054 in its current form. This new course - JUR-3055 <i>Uses of the Oceans</i> - addresses a</p>

	<p>suggestion of the external evaluation committee of including a <i>“more systematic focus on the role of international institutions in the law of the sea, the role of non-state entities in the law of the sea, and the implications of the law of the sea gaining closer and closer ties with other areas of international law”</i>.</p> <p>The exam format in the revamped JUR-3055 does not require change. The moot court held in JUR-3055 should be transformed into a mandatory assignment.</p>
